Presidents Report

This will be my last President's report, as my three-year term (self-imposed) comes to an end at this year's AGM. I would firstly like to thank the members of this great association for having faith in me over the past three years to lead this association. I take great pleasure in reporting to the members of the association the activities of Executive and other matters for the season 2015. This year was yet another interesting year, with plenty of challengers, thankfully most off the field not on.

The highlight for the year for me was seeing Sarah Corrigan awarded an OAM for services to Rugby, this is an outstanding achievement and is true recognition of the services Sarah has provided to Rugby.

This year saw the expansion of the Junior and Monaro completions with the addition of Young U16 and U18, into the Junior competition and the South Coast added to an expanded Monaro competition. These additions added more complexity to the already tight appointments.

The major event for this year was the introduction of the Match Official Payments Programme. Although there were some frustrations with the administration of the programme, the end result saw Match Officials finally receive payment for the outstanding job they do week in week out. We could not have got this programme into place without the tireless support of the Executive, Dennis Beissner, Owen Keane and Simon Carol. There were of course many others guiding and supporting the MOPP Committee and to those, I also say thanks. Obviously it takes 2 to tango and the support of the ACTRU, ACTJRU and all clubs Junior and Senior is also very much appreciated.

The Executive also lost a member this year with Ariel Miners resigning, due to him moving interstate. Ariel was a great member of the Executive and we wish him all the best. We were very fortunate to find a very capable replacement in the form of Irene Jones.

Coaching Grading and Appointments Committee and Referee Coaching

Brett Bowden again took up the mantel of Chairman of the Coaching, Grading and Appointments committee. Brett was abele assisted by Greg Saphin as the Referee Coaching and development Coordinator and Jeff Stone as U19 Appointments Coordinator.

Behind these three were a team of Referee Coaches that week in and week out assisted those in the middle constructive feedback and reporting. Thank you very much to all who put in the time and effort this year. I look forward to working with you in the field again next year.

Congratulations to all those Referees who progressed through Panels this year, however in particular Matt Hogan, Ben Rahilly, Ben Nelson and Reece Henshaw, all of whom were appointed to the A Panel. Of the four Ben Rahilly is yet to make his First Grade debut due to the exchange to New Zealand.

I personally would like to thank Brett, Greg & Jeff for their efforts this year. It is mostly a thankless job, yet they all managed to get the job done without too many issues.

Referee Abuse

I am pleased to say that Referee abuse cases were less this year, yet any is too many. ACTRRA is always working with the Clubs and the Brumbies Administration to stamp out any forms of abuse, and that will continue. It does however rely on the members of the association to report the abuse. Please ensure next year if you suffer abuse report it. Otherwise you are more than likely condemning the next Referee to the same abuse.

Exchange Program

This year we saw the incoming exchange of Scott and Nathan from the Canterbury and South Canterbury regions of New Zealand. As always it was fantastic to get Referees from our Eastern neighbours. I would like to thank all who opened their doors to Scott and Nathan for their hospitality and generosity.

The outbound exchange was not as successful with Michael Rahilly and Greg Saphin travelling to the Waikato region. Unfortunately due to personal commitments and confusion with the Waikato Ben and Greg did not get the standard of the games we would have normally expected.

Again the Association is trying to keep up with Social media to ensure relevance and connectivity with our younger members. With Facebook and Twitter pages the association is trying to ensure we keep up with modern trends.

Training and Development

Trainings this year have been a focal point for the association with the majority of trainings being well attended. We are looking at changing training next year to allow for the slowing in Thursday night participation.

The development nights were again well attended, although we always have room for more. The content put together by, Brett was of the usual high standard. Again we will look at improving all content and participation next year.

The lack of an RDO this year seriously effected the association this year and we cannot go another season without an RDO in place.

Coaching, Grading and Appointments Chairman's Report

2015 was set up for a changing of the guard and it was promoted to those coming through as an opportunity to grab their chances and see where you finish up.

From the beginning of the season - Queanbeyan 7's, right through to the NRC and Griffin games in the post-season our future took the challenge and refereed well for the entire year. This was evident with both James Morris and Matt Hogan being selected to referee at the Schools Championship and then both receiving appointments as AR's in the NRC. James continued his extended season with being appointed to Australia A v Samoa in a Schools international, as an association we hope this is just a precursor for things to come for him. We were represented at the Schools Championship from our coaching ranks with Scott Izod making another appearance. This is never surprising as Scott continues to be one of our best coaches with his practical and common sense approach to the game.

It was also pleasing to have another of our coaches receive an ARU appointment, with Steve Peak being appointed as a referee coach to the Hottest 7's in the World (Darwin) in January 2016. Steve was sidelined for the 2015 season with what he has described to everyone as a "serious" foot injury! But to the associations benefit he has proven to be an excellent referee coach and certainly had an influence on the progression of a lot of our referees this year.

At the first Coaching & Grading meeting this year, it had been determined that we could have 4 referees make their 1st Grade Debut in 2016. We were on track with this goal with Matt Hogan debuting early with great consistent performances that began preseason and then in the early rounds of the competition. This was then followed late in the season with Ben Nelson & Reece Henshaw also making their debuts. Both Ben & Reece made trips to Sydney to referee outside their comfort zones and pick up some extra coaching, this certainly helped them as they refereed very well all year. If it wasn't for holidays, an exchange and then running out of games Ben Rahilly who also made the A Panel this year would have made his 1st Grade Debut. Michael will have to wait until next year for this honour, he did however show he ready for this step up with a very good performance in his Griffins v Newcastle game in an NRC curtain raiser.

The season was successful through the support of our Executive, they always put our best interests at the forefront of their decisions. Thanks also must go to our referee coaches! Referees get the fun by running out in the middle, the coaches obviously get the satisfaction on watching their performances and then help them be better. If anything needs to be considered from this point on, it would have to be to a consideration to develop our coaches at the same rate we develop our referees. Development of referees and coaches must be parallel.

Our coaches were well managed by Greg Saphin and his diligence throughout the season made sure we always had coaches at grounds with referees making a difference. If you look at ultimate commitment, you can't look past our coaches! Rain, hail or shine they are there supporting our referees. Canberra doesn't have the nicest weather during winter and you could forgive anyone for wanting to be in a warmer place other than a cold grandstand watching someone run around. But ask these coaches and they'd only want to be in one spot – helping our future referees. Is thanks enough? Probably not.

U19 Coaching and Grading Coordinators Report

Well what and interesting year this was, with referee numbers down, the loss of the RDO from the Brumbies just to name a couple of issues. Referee number were down about 30% on last year and the loss of the RDO meant that no Referee Kids Courses were run until late in the year

The Brumbies Administers report has provided a summary of the season's appointments statistics will show we managed to cover most of the game throughout the season. I thank Amy for her efforts in this.

Unfortunately this year as per the last couple of years the appointments were not out as early as I would have hoped. There are quite I few reasons for this happening but I am looking into some strategies to rectify this for next year.

Stables

Unfortunately this resource was not adequately used this year due to a number of reasons but the main reason was due to the loss of the RDO as well as numbers of personnel. The stables software is a great resource that aided in the ability to capture reports on referees as well as the ability to provide mentors for our newer and younger referees. I would ask everyone to their hand to assist in this. The system is by no means perfect but will become more effective with just a few minor changes to the way we do some processes.

Development

We were able to run a pre-season and finals series seminar this year but as per usual the attendance at this was disappointing with less than one-third of active junior referees making an appearance. These were the same referees that I have seen attending these seminars for the last couple of years and in some way reflected on finals appointments.

This year we had all the usual suspects doing the rounds of the grounds and referee coaching, starting at OMG it's early on Saturday morning and finishing when the sun was setting. I would like to thank you all for your time and input for the development of all our members. I will not name you personally because I will more than likely miss someone but thank you all.

Scholarship and Watch Group Referees

This year we reinstituted the watch group for referees we are looking at for scholarships the following year and I feel it was well received and managed. This due to the mainly to the efforts of Steve Peak who ran both this and the scholarship referees.

Unfortunately 2 out of 3 scholarship referees were injured early on during the season so did not get the full benefits of the programme, hopefully we will have better luck with this group next year

Referee Abuse

This was an issue once again this year with some teams and clubs, just not getting the message that if is not acceptable to abuse a referee. I still cannot comprehend how some coaches especially at the younger grades think it is acceptable to abuse a young, inexperienced referee.

I think there is still a great deal of work to be continued on from the good work conducted last year and the ACTJRU has start to hand down some serious sanctions so hopefully this is going to deter some of the people or at least make them think twice. I can assure you all I take this seriously and am looking into how we handle repeat offenders and teams.

Finals and Grand Final Games

Congratulations on everyone who was appointed to a game for either the semi-finals or more importantly a Grand Final, whether it was as a referee or an AR. I feel we got the appointments right in about 95% of the case with only a couple of games not refereed to a standard we were happy with.

This year I took the approach to align the junior process with the seniors in that the best referee would do the grand finals and only qualified ARs would be involved with the grand finals to provide the best service we could to the teams competing in the finals. This resulted in the games from under 16 up, having the referee appointed from the senior



referee panel and then having a flow on effect that referees may have done I final at a level lower than they have done during the year. I make no apologies for this if you feel that the final was below your level but we were out to provide the best referees for the best games with no refereeing decisions deciding finals, the teams decided who were best on the day. The decision to use only qualified ARs resulted in some having multiple grand final appointments, this process is going to stay in place for next year so the message is short and sweet, if you want to be considered for involvement in a grand final do the AR level 1 course it will improve your chances. The disappointing thing about this is that some AR's did not perform their duties as they should have and support the referee as they should have, this was the case with both junior and more senior AR,s.

Final Wrap Up

Congratulations to all award winners at the end of year awards and all referees and coaches on what was achieved for the year we have a good base to now work on.

I would like to personally thank everyone who has help me through the year and given me guidance and at times pulled in the reins to stop me getting in trouble and going off half-cocked which does occasional happen.

I look forward into continuing the role next year and building on what we have already started to develop. If you have any ideas that may help improve anything we have in place or we may need to address feel free to contact me.

Have a good off season and I look forward to seeing you all again next year.

Brumbies Referee Administrator Report

Introduction

Even before the first blow of the whistle on the 2015 season the Brumbies Rugby Referees Department and ACT Rugby Referees Association (ACTRRA) were in full swing. The Brumbies Rugby Referees Department staff changed this year. Amy Allpress came into the role of Rugby Services Administrator and it was early on in the season when the Referee Development Officer for Brumbies Mark Snow moved on from Brumbies. After approximately 10 years with the organisation.

Following Mark Snow's Referee Development Manager role being made redundant, Mark was offered an alternative Referee Development Officer position but declined. Consequently Brumbies Rugby entered discussions with the Australian Rugby Union around support for a jointly funded Referee Development Officer role in partnership with the Victorian Rugby Union. This approach would enable the attraction of a suitably qualified and experienced individual in a full-time capacity to drive recruitment and development initiatives across junior and senior referees for this extended region. Unfortunately discussions stalled and consequently an alternative arrangement was explored through the Australian Rugby Union in collaboration with the NSW Rugby Union. Despite a firm commitment from Brumbies Rugby and the ARU to fund this approach this direction also failed to materialise. Throughout this period of discussion Brumbies Rugby employed Brodie Ingram and Steve Peak to drive key development programs in the area of junior recruitment and student scholarship referee support. This ensured equivalent coverage in the temporary absence of the previous part-time development role.

In 2015 the Brumbies Rugby Referees Department looked hard at focusing on recruitment and development of the referees with help from the members of ACTRRA. Recruiting referees through referee courses, particularly the refereeing kids' courses which are a great initiative to gain beginner knowledge on refereeing and to start out as a trainee referee; with the hope that through positive experiences refereeing and development opportunities, these referees will grow into senior referees. This being vital to rugby at a community level. Referees were afforded the opportunity to do a workshop with Chris Nunn. This was an education incentive to upskill and develop the referees we have in Canberra, hoping to give them another perspective on refereeing. Referee coaches are a key component of the development focus. To better assist them with mentoring Jamie McGregor from the Australian Rugby Union (ARU) came down to Canberra and gave a seminar on the referee coaching database to ensure proficient and regular use and by extension means beginner referees have more opportunity to gain knowledge on their refereeing. The reports in RRIMS was a significant increase on last year. This mentoring extended into the ARU School Student Scholarship and the Brumbies Watch Group where there is recognised potential as future leads of refereeing.

Recruitment and Retention

This year ACTRRA had a total of 153 Referee Members this includes 12 Life Members. ACTRRA welcomed 29 new members this year but lost 70 existing members that were with ACTRRA until season end 2014.

Through Refereeing Kids Courses this year we recruited 58 potential new referees that were encouraged to sign up with ACTRRA.

Accreditation/Courses

In 2015 congratulations goes out to those referees who further developed their refereeing qualifications. Geoff Rodgers who completed his Level 2 Referee qualification. Three referees completed their Level 1 Referee qualification in 2015.

Coinciding with the focus on development and recruitment the Brumbies Rugby Referee Department provided 7 beginner Refereeing Kids Courses in 2015. 2015 offered seven (7) Refereeing Kids Courses and four (4) Foundation Courses, comparable with what was offered in 2014. Brodie Ingram was tasked with conducting the Referee Kids Course for the second half of the season. Across June, July and August Brodie directed 6 of the 7 courses. All 6 were held at different venues across ACT and NSW. 48 people partook in the 6 courses within 3 months, which is a fantastic turn out given the short space of time and due to them being held towards the closing of the Rugby season. From all 7 courses run over the course of this year we had a total of 58 participants. The biggest turnout was Broulee with 13 and the lowest was Gowrie with only 5 attending. The Brumbies Rugby Referees Department thanks Brodie Ingram for his help running the Refereeing Kids Courses.



Development

The ACTRRA conducted internal development nights run by Brett Bowden. These nights were held once a month on a Tuesday evening at Canberra Grammar School and existed to up skill the ACT referees. It was evident by improved performances from both referee coaches and referees, that those who attended the development nights benefitted from these sessions. The sessions were predetermined at the beginning of the year, each one focusing on a different topic. Other points of discussion were incorporated into development nights on a monthly basis. These discussion subjects were based on feedback from players, coaches, referees and referee coaches, these subjects were usually around game trends that needed immediate discussion or clarification. Topics that were areas of importance for development nights this year were Scrums, Breakdowns (TR&M) and Lineouts - concentrating on time and space. Each development session had extensive DVD footage from our local games to help referees gain a better understanding on the laws of the game, enabling them to better manage games when they are refereeing. It was important that we used local footage, so coaching came from games referees could relate to. Senior referees took on a mentoring role with development nights and got involved with helping out beginner referees. The Brumbies Rugby Referees Department thanks Brett Bowden for his significant contribution with development nights and further progressing the ACTRRA members.

Education and Training

On 3rd June 2015 the referees were given the opportunity to do a workshop with Chris Nunn. Chris Nunn OAM is an international coach and was the Chef De Mission for the Australian Paralympic Team in Sochi 2014. Over three decades Chris has developed an understanding as to how people contribute towards creating the best competition environment possible where athletes can perform and believes strongly that officiating is critical to athlete development. Chris has enormous experience in sport across all areas. During the workshop Chris did with the ACT referees he highlighted the necessity for officiating at the highest level regardless of the grade of competition which is being contested. He shared experiences and thoughts regarding how to manage yourself and those around you during a competition.

The feedback forms that the referees were asked to fill out after the workshop was extremely positive. Overwhelmingly 100% of everyone that attended were grateful and happy with what the workshop had to offer them in regards to their refereeing.

Mentoring/Coaching

Earlier in the year ACT Referees were given the opportunity to attend a development night with Jamie MacGregor Match Official Programs Manager from the ARU. Jamie came down to Canberra and gave a seminar at Brumbies HQ to those ACT referees that were available to attend. The seminar was a great opportunity for referees to gain more knowledge on refereeing rugby at junior and senior levels. The seminar also included information on the RRIMS database, giving referee coaches the information they needed to make use of this valuable database which assists with mentoring, development and coaching of up and coming referees. It is evident in the increase report numbers on RRIMS this year that referee coaches gained a lot from Jamie's seminar. At the time of this report (16th October 2015) 138 reports had been written on up and coming referees which is a 35.3% increase from last year.

In 2015 we had three School Student Scholarship (SSS) Referees. These were Thomas Brown from Canberra Grammar School, Mitchell Colbert from Marist College and Leo Kaczmarek from St Mary MacKillop. This is the second time the boys have been successful in attaining the ARU School Student Scholarship, which is a testament of their enormous potential. The ARU School Student Scholarship was introduced a number of years ago as an initiative to raise the profile of refereeing through schools. The program is a way of providing encouragement for young referees and to help keep them interested in refereeing once they complete school. James Leckie an ARU referee presented the boys with their apparel on the 1st May 2015 at the Brumbies home game against the Waratahs. Craig Leseberg General Manager for Community Rugby and Rob Boyes ACTRRA President were also involved in presentation proceedings congratulating the boys on their achievements.

In the absences of a Referee Development Officer Steve Peak a Level 2 referee coach and member of the ACTRRA agreed to assist with development of the ARU School Student Scholarship Referees. Steve took on these responsibilities approximately half way through the season.



The students selected for the ARU School Student Scholarship program were involved in a range of activities designed to improve their knowledge of the game and enhance their performance as referees. One of these activities is helping with No 6 referee duties at the Super Rugby games, exposing them to a higher standard of rugby which they may never have otherwise been exposed to. Unfortunately Mitchell suffered a significant knee injury early in the season rendering him unable to referee and only got to experience a couple of No. 6 duties before his injuries ruled him out of partaking in any other activities associated with the program.

Along with Mitchell, Leo also did No. 6 duties at Brumbies. Leo unluckily injured his leg and disappointingly he has not yet returned to refereeing.

Thomas Brown was the only SSS Referee left standing at the end of the season. Tom was active in refereeing community club rugby while engaging with his older peers and referee coaches to gain knowledge on refereeing that would help to future develop his refereeing skills. Unfortunately due to school commitments and finishing year 12 Tom was unable to attend various other interstate development opportunities provide by the Australian Rugby Union (ARU) through the SSS Referee Program. Tom's accomplishments within this program did not go unnoticed and was the successful recipient of the Will Boyle award for the most outstanding Scholarship Referee, at the ACTRRA Presentation Night this year.

Steve Peak also spent some time helping out with development around the Year 11 Referee Watch Group. This is a group of year 11 students that are identified as potentials for the SSS next year and are given extra development opportunities to assist them to succeed as they further their refereeing. This year's Watch Group were; Reuben Keane, Mitchell Beissner, Adam Onus, Lilly Pearson, Ben Gillespie, and Nic Marshall. As part of the program Steve ran two weekends of AR training as a team, teaching this group about the Communication Equipment and acting as AR1 and AR2 for Colts and 2nd Grade games and then having team feedback sessions with the referees. Adam was also AR2 for half of a 1st grade game as the appointed referee was injured. Both SSS referees and the Brumbies Watch Group also helped with various gala days that were great for development as the repetition of games gave them the opportunity to practise their skills and quickly put in to practise feedback. The Brumbies Watch Group and SSS referees felt that this was very worthwhile. It was unfortunate that due to other personal commitments and communication issues with various people involved in the groups meant development opportunities were limited to what they could manage and not necessarily what would have been desirable. The Brumbies Rugby Referees Department thank Steve Peak for his work with the SSS Referees and the Brumbies Watch Referees.

Appointments

In 2015 senior appointments were made by Brett Bowden with little disruption after the initial appointment. With junior appointments there is always last minute withdrawals, game time or venue changes and family commitments that make it harder to get referees covering all junior games.

It isn't an easy task doing junior or senior appointments and the Brumbies Rugby Referee Department thank Brett Bowden and Jeff Stone for their efforts with this task. The Brumbies Rugby Referees Department also thank those referees that did fill appointments last minute or on game day in the unfortunate circumstance when there is a game uncovered by a referee. Thank you also to those referees who made the effort to travel to regional areas to referee matches and to referees who travel into Canberra to referee.

In 2015 there was a total of 1340 junior games played and 392 senior games played. Of those games 737 junior referee appointments were made and 388 senior referee appointments.

Well done to all referees this year whether a new beginner referee or a senior referee your efforts in 2015 were very much appreciated.

Appendix A

Post Season Review Notes:

1. Courses

It was mentioned that only the refereeing juniors (midi/mini) course was run during 2015. No other courses (even AR. 1/2) courses were run during the year as no RDO (DB post season note: Snowy ran a level 2 course in February/March as my son attended it. However it is unknown if the course attendees had their attendance/qualification recorded with ARU? This may need checking.)

Concerns were raised that if no RDO is appointed soon then no courses are likely to be run in ACT. In 2016 this will not be satisfactory and the ARU need to be advised to ensure some courses are conducted otherwise ACT rugby refereeing will undoubtedly suffer (especially recruitment).

2. Junior MOPP

It was agreed that the Junior MOPP was not effective or efficient during 2015. In regard to the payment process and proof of games, there was considerable discussion and explanation as to what occurred. It was generally agreed that the admin process in 2016 must be changed and be simpler as what was experienced in 2015 was ludicrous.

It was generally agreed that there needed to be single and trusted database of the appointments scheduled and completed. At this stage, until there is a new reliable system, then the current database should be used as the factual data and ACTJRU need to be convinced (somehow) to trust this system.

There was discussion that a paper-based recording of game/sign on sheets puts an unnecessary admin burden onto too many.

There was a side discussion on YC/RC reports not being completed and that ground/game sheets could be used to track these. This did not seem useful method when we have an online notification form and that it requires more/better education about notifying the correct people.

7s/10s payments were discussed. It was generally agreed that these pre/post season games are a useful development tool for referees and it can be up to the individual as to whether they participate as ACTRRA does not need to appoint to these. Though it was agreed that those needing referees for their tournament should provide better/proper facilities to the referees and perhaps they need to be reminded.

3. Travel Allowance (TA)

Discussion to have payments for travel in either direction. Either Canberra to Goulburn or Goulburn to Canberra (for example) or any other outlying areas and for referee coach to receive travel allowance also.

ACTRU should pay TA for referee's to come into Canberra for development. ACTRRA will try not to have cross over of referee from outlying area's to Canberra.

To change the requirement in the MOPP agreement that says "pay those travelling from Canberra"

Appoint referee's locally where possible.

If a referee is playing at that location then they may not be entitled to travel allowance or there can be some compromise if they get payment for one way and not both ways.

4. Referee Training

The number are always lower on a Thursday night. BB suggested trainings Tuesday and Thursday during daylight savings on the grass, then once day light savings end only train only Tuesdays.



BB to draw up a training program for referee's to use on their own or in smaller groups or pairs.

5. Appointments

Seniors seem to be ok as usually out 2 weeks before hand. Need all senior referees to check the final version of appointments prior to the weekend ant rely on the draft appointments as still being correct?

Any game changes need to be passed onto the referee.

Need to advise at the preseason session how the appointments are going to work and confirm that the final version needs to be checked for changes.

Referee coaching coordinator needs to be advised of changes also and received draft early so can appoint referee coaches on the draft appointments.

That referees are aware that they will have a referee coach at a game in advance rather than just on the day.

Under 19 referee the coordinator needs the games loaded into the date base earlier. This will then give the coordinator more time to cross reference referee's that play as well. Questions asked if the data can be loaded on an Excel spread sheet. At the moment the appointment sent out are only 80% correct.

There was a longstanding agreement from Brumbies admin that the game data would be loaded by Monday but this is not being done, need to look at getting a better process in place for next season.

Need final changes out by Thursday evening. Is there a better way of communication appointment to the younger referee's as they don't always confirm availability till the last minute? Consider insisting that parents e-mail addresses are used as well as the students.

There is a need to make sure that all databases are up to date and the correct emails are on the system.

If there are U19 games without a referee then we should have the games without referee's emailed to the whole of the referee association.

As to the general process of appointments and data being loaded on the system we need to have clarified by the Brumbies Office. It is understood that at this stage 50% of Amy's roles is for referee needs.

6. Increased Transparency

Publish referee grading and the mechanism required to be graded at that level. Make a note that Panel grade is on performance.

Referees are appointed to a game based on the referee required on the game they are not appointed because of a position in a panel.

If a referee has a concern on their grading then they can talk to both the referee coach and the referee coordinator.

7. Comms

Sheets are not being reviewed and faulty comms gear are being replaced in boxed unrepaired. Need to be carefully check so that all parts are in the right boxes so that one set of comms gear is not left with our ear pieces. Referees to make sure that full set of gear is returned. There was some discussion on who is responsible for getting the gear fixed.

Look into the cost of hiring better comms gear.

Suggestions that ACTRRA take over the Comms kits.

8. Presentation Dinner

There was a lot of discussion over whether we should keep with the traditional dinner, as there has been decreasing number attending the dinner.



There was discussion on whether moving the dinner to the preliminary final night. It was thought that most of the under 19 referee awards would be known at an earlier date and could be awarded if dinner moved forward.

There is a minimum spend of \$5,000.00 if we were to use the Press Club again. May need to look at a different location or changing the type of presentation.

9. Recruitment & Retention

There were question raised about the need to advertise /market refereed recruitment.

The need to go into schools and run referee courses.

At development nights and other activities make the Under 19 referees feel welcome. Make the development pathway clearer to them.

10. Exchange

The referee ability needs to be advised to the club accepting the exchange referee. This was decided as necessary after one of the referee's on exchanged to Waikato was used to referee an U13 & U15 age tournament. It needs to be advised that these referees are there for development.

Usually have a positive experience in New Zealand. Are the right questions being asked so that the right information is being provide to make informed decisions.

11. Uniforms

The association may need to be self-sustainable. Most companies do their budgets in May /June for the flowing financial year. We may hear further from some companies later.

National Plumbing may come on board with further funds. 4 package's on offer for sponsorship – involves 3 year commitment.

Sponsorship is influenced by who the brumbies use, but are able to obtain our own sponsorship. Brumbies provide shorts, jersey and socks. Currently sponsors Brumbies have the funds go into a central pool and then disbursed.

Need to secure sponsor for 2017. Work nearly 12 month ahead. There will be a new change in jersey for the 2016 season with a round neck jersey. Currently in discussion with Classic for supply of uniform. We received a 25% discount if we order through Brumbies.

12. RDO

There needs to be one appointed before the 2016 season.

13. Referee and Referee Coach Development

May need to work on exchange options look at both New Zealand and interstate with in Australia.

Coaching- work on a buddy system

Look at scholarship referee's work on a system to identify them, RDO as a guide but not fully responsible for the decision.

Can be some crossover in panels and there needs to be better communication between Senior panel and junior panel referees.

The development process between both senior grade referees and junior grade referees should be similar.
